Course Title: Intermediate Accounting I

COURSE DESCRIPTION

Designed for accounting and finance majors, this course combines a study of the theory, rationale, and objectives of corporate financial reporting with an examination of current reporting principles. The aim is to develop an understanding of the strengths and weaknesses of corporate financial reporting, particularly from the viewpoint of the consumer of such financial information. Emphasis is placed on the analysis and understanding of publicly available financial information, rather than on the mechanics of construction of financial statements. Nevertheless, there is still a great deal of mechanics and problem solving in this course. Lecture material will closely follow, but not exclusively follow the textbook. However, several controversial and theoretical issues may be included in classroom discussions. The student will be responsible for these additional areas as well as the textbook material assigned.

LEARNING GOALS AND OBJECTIVES

This course is designed to help students develop accounting and analytical skills and knowledge.

The course consists primarily of lectures and problem solving and is designed to help students develop an understanding of the major elements of financial accounting needed to make effective business decisions. The course closely follows the material presented in the textbook. However, additional material / topics will be covered in class. Students apply what they are learning by completing assigned homework problems, taking exams and by attending class and collaboratively solving self-assessment exercises. These teaching techniques are used to ensure that students meet the learning outcomes listed below.

- A. Students will demonstrate understanding and analysis of the accounting information needed to make business decisions and to issue reports to market participants.
- B. Students will be able to critically evaluate, analyze and interpret information needed to solve business problems and make rational economic decisions.
- C. Finally, students will be exposed to multiple alternatives in financial accounting and reporting. Some alternatives will increase reported income while others will reduce profit. The discussion of management discretion in selecting accounting methods will allow students to develop the ability to understand and evaluate ethical issues and situations to make business decisions with integrity.

ATTENDANCE AND PREPARATION POLICY

Attendance. I expect *100% attendance*. I will allow one unexcused absence. **Unexcused absences** (beyond one) will result in **escalating penalties**: 2% reduction of the course grade for the first unexcused absence, 4% for the second, 8% for the third, etc.

CLASSROOM CONDUCT

- a. Be warned, questions will be asked “on the fly” at various points during each class meeting. Chapters should be read *prior* to the class.
- b. Your learning goals are:
 1. To critically analyze all accounting standards covered in this course with “professional skepticism.”
 2. To fully understand the theory underlying each accounting method covered.
 3. To relate and link several parts of the theoretical foundation and apply these concepts when solving mechanical problems.
 4. To tie the effects of each accounting procedure to the financial statements and selected financial ratios using Financial Statement Modeling (Articulation) Worksheets. Place emphasis on the cash flow effects of the event or transaction.
 5. To approach all portions of the course material from a user perspective
- c. **Electronic devices are not permitted during class.** If you are caught using any electronic device without permission, you will receive a cut (unexcused absence) for that class (see attendance policy above).
- d. You are expected to arrive on time and remain for the entire class. If you expect to be late or leave early, please let me know in advance.

There are three (3) exams in this course: **Two (2) semester exams** and **(1) comprehensive final exam.**

Content of Exams: All exams will consist of theory and problems. *The multiple-choice questions and problems will be similar to the questions and mechanical exercises covered during class and included in the assigned problems.*

Other Factors: As noted earlier, your grade will be reduced due to excessive absences, tardiness and the use of electronic devices in class.

Extra credit opportunities are not available.

Grades for exams are typically **posted on Canvas within one week** of the exam date. Exams are **NOT** returned to the student, however, the students may see their exam in my office, by appointment.
