Course Title: Large-Scale Business Data Analysis

COURSE DESCRIPTION

This course introduces students to fundamental statistical techniques for analyzing large-scale business data. The main goal is to provide systematic training in statistical models for massive datasets as well as programming and exploratory data analysis in real-world settings. The course equips students to develop context-sensitive models and perform model checking and diagnosis. For each topic, the course covers enough theoretical background so students can understand how to apply and interpret each class of models, and then illustrates how it's used via hands-on exploratory analysis using R.

Below is a list of topics to be covered. Topics with a star (*) will be covered if there is enough time.

Topic 1: Review of Probability, basic Bayes classification, and regression; Introduction to R

Topic 2: Overview of simple classification methods: Naive Bayes method and k-Nearest Neighbor

Topic 3: Controlling model complexity and Bias-Variance Tradeoff

Topic 4: Classification by trees

Topic 5: Maximum Likelihood (ML) and Maximum a Posteriori (MAP)

Topic 6: Review of Linear Regression

Topic 7: Classification with logistic regression

Topic 8: Nonparametric regression and classification

Topic 9: Neural networks and deep learning (*)

Topic 10: Unsupervised learning and clustering (*)

LEARNING GOALS AND OBJECTIVES

1. To approach problems data-analytically: to think carefully and systematically about whether and how data can improve performance;
2. To be able to interact competently on the topic of data mining analytics: to know the basics of data mining processes, techniques, and concepts; and
3. To receive hands-on experience mining data. Throughout the curriculum, special emphasis is placed on techniques that are relevant to large volumes of data.

PREREQUISITES

- Knowledge of basic statistics as taught in 136:385 course. You especially need to be up to date on regression.
- Knowledge of some programming language. We will use the R as our main programming platform, but if you don't know R, it will be easy to learn it if you already know some programming language.

ACADEMIC INTEGRITY

ATTENDANCE AND PREPARATION POLICY

- Class attendance is essential for your success in this course. Therefore, I will take attendance each class, and attendance will have some effect on your final course grade. My goal is to discourage poor

attendance, not to reward perfect attendance, therefore your grade will be affected negatively if your attendance is poor.

- **How it works:** If you miss five classes or less, your final grade will not be affected. If you miss six classes or more, I will subtract an amount (to be decided later) per missed class (beyond the five allowed) from your final course grade.
- **It is not necessary to inform me if you will be missing a class unless you are missing an exam.**
- **An absence is always counted as absence even if it is because of illness, job interviews, family emergencies, etc. The five absences are meant to cover these kind of “excused” situations.**
- Exceptional situations in which you have to be absent for a long period of time, e.g. long medical conditions or surgeries, will be treated separately on a case-by-case basis.
- If you miss an exam due to illness, please contact me to see whether any accommodation is possible. Severe illness or personal emergency is typically the only reason I make accommodations, and there must be written, verifiable documentation. Otherwise, you will receive a zero score on the missed exam.
- Severe weather and other cancellations: Your primary source of information for whether the campus is open. I will also send an announcement as soon as possible if classes are cancelled.

- I am planning to give 5 to 6 homework assignments.
- Assignments policies will be announced when the assignment is posted.
- All assignments will be submitted via Canvas. I will not accept assignments sent by email. - Due to the logistics of tracking large number of students, there is no credit for late assignments.

GRADING POLICY

- Your course grade will be based on an aggregate score:
 - 30% Homework average score
 - 35% Midterm
 - 35% Final exam
- I reserve the right to make changes to the above grade calculation schemes.
- Students with particularly poor attendance or performance after the midterm will be issued warning grades.
- If you miss six or more classes, some points will be deducted from your final grade (See class attendance above).
- I assign letter grades based on your overall aggregate score. I do not use fixed cutoff values, but instead use my judgment to select cutoffs that make sense for each particular course. The cutoffs will never be higher than the “regular” cutoffs, that is, an “A” will never start above 90, and so on.
- I do not offer extra credit work to improve grades after they have been issued. Such a policy is not fair to other students: If I were to offer extra credit to a student, I would have to do so to every student whose grade was below “A”.
- All grades will be communicated on Canvas. No grade related information will be provided by email. All grade related information will be provided in person via appointments. It is expected that you are respectful when you review your grade with me and accept the grade you have earned. Please do not use abusive language in email or in person. Any instances of that will be reported according to university guidelines.
