

Supply Chain Management Course Number: 22:799:680 Course Title: Supply Chain Trends

### **Course Description and Objectives:**

This is a pop-up class, meaning that the topics covered will change each time the class is taught. We focus on the important supply chain issues of our time. The class is centered around cases that are presented by guest(s) who are supply chain leaders in their organization during online synchronous class meetings. We will focus on how companies are building processes and systems as well as solving challenges that will carry them into the future. Spanning across the supply chain, leading companies use multiple systems to ensure visibility, efficiency, and resilience. Over the course of the semester, we will have 10-12 cases covering multiple aspects of the supply chain. Each class will roughly follow this outline:

#### Course Format:

- In the first part of each class session, the guest will present the business problem, and the students will work in groups to develop solutions.
- In the second half, the students present their solutions, and the whole class together, will synthesize the best approach to handle the problem that was presented.
- Finally, the guest presenter will debrief the class towards the end of the class time with possible solutions that worked in the actual situation.

# **Learning Goals and Objectives:**

- Strengthen your problem-solving and develop critical-thinking skills
- You will be able to walk away with a "playbook" for how to handle disruptions of any kind, but especially the ones that we are still facing during this pandemic
- Learn to effectively communicate, collaborate, and present

### **Class Structure**

**Course Delivery Mode:** synchronous remote (SR) – we meet on Zoom every Tuesday evening from 6:00PM to 9:00PM
