While this experience will rely heavily on "the country as classroom") we will have some formal times during the trip set aside for class discussions, etc.

The NY Times stated that "Study abroad is the new must-have credential." Being able to speak with potential employers or your own employer about your international experience sets you apart from others and gives you a competitive advantage. In today's global environment, companies are looking for people who have had exposure to other countries, other cultures. Globally fluent graduates are essential to competitiveness. In the future, those who have not had international exposure will be at a disadvantage.

#### **Course Description**

The objective of this course is to provide a comprehensive and hands-on understanding of "Doing Business in Israel. It complements your learning in different courses and concentrations that are offered at the RBS. A particular area of focus is the Israeli Entrepreneurship Ecosystem, which, according to a CNBC story in April 2016 "Israel has more tech startups and <u>venture-capital</u> funding per head of population than anywhere — even the United States." <u>http://www.cnbc.com/2016/04/05/israel-may-give-silicon-valley-a-run-for-its-money-commentary.html</u>

By the end of the course, you will develop a deep understanding of:

- Social, economic, cultural and political environment in Israel, and how the same affect local and foreign firms
- A discussion of innovation ecosystems (there's more than one), research and development and the intellectual property regime
- Market dynamics, competitive landscape and consumer behavior in Israel.
- Israeli financial markets, banking system, as well as the monetary policy, fiscal policy and exchange rate regime in Israel.
- The transportation and logistics infrastructure
- The labor market and human resource management issues.
- The interaction between business, society, IGOs, NGOs and the government; this includes a discussion of characteristics of Foreign Direct Investment

This unique course features a study trip to Israel from January 2 to 15 where students will interact with business people, entrepreneurs and government officials. This course is open to undergraduate students first, and if space permits, a limited number of MBA students, for anyone interested in doing business in Israel, or knowing more about one of the most important developing economies today, and for aspiring/current entrepreneurs, this course is a must.

#### **Destination: Israel**

Israel has a complicated and remarkable history punctuated with extraordinary events that are demonstrations of the gamut of human experience. And yet the modern "Startup Nation" is one of the largest and fastest growing economies in the world. It has been described as a modern economic miracle, and its physical infrastructure, established financial and tourism sectors and emerging technology sector are all evidence of its bright economic future and to the large number of business opportunities. However, numerous social issues stemming from years of turbulence in the Middle East, with range of peaceful to hostile relations with its neighbors, along with its struggles to resolve the decades-long issue of an independent state for the Palestinians and other present important challenges that could undermine Israel's continued emergence as an important world player in innovation in a variety of fields; however, less well known is its outreach to create a successful partnership with its Palestinian neighbors to foster entrepreneurship via an Hybrid, the Israeli/Arab Incubator in Nazareth, it's robust social innovation sector fostered by Israeli government, USAID, and private sector investments. These efforts provide increased entrepreneurial and economic opportunities for women, at-risk youth, the intensely religious Jewish populations that don't typically enroll in colleges, and virtually any other disadvantaged population. Collectively a course of this nature offers an intensely challenging and enriching experience that's about much more than just "business basics"; it's about how to confront the challenges faced by a growing economy with real political and social challenges, and how innovation and entrepreneurship, fostered at both the government and grass roots levels, seek to solve those problems. This is why such a course is a "must" for entrepreneurs who want to expand their personal and professional entrepreneurial knowledge and skill set.

## **COURSE OBJECTIVES**

The course is designed around three main activities:

- First, through our in-class sessions, we will develop an understanding of what is going on in Israel and the nature of doing business there. In order to accomplish this, we will read reports, books, articles, and case studies. We will learn from regional experts and begin to analyze the economic patterns and outlook for Israel and the region.
- Second, on the in-country portion of the course, we will conduct onsite visits to Israel and multinational businesses, innovation centers, incubators, accelerators, venture investors entrepreneurs, and government agencies have learning sessions in which we learn about key social, economic, and political factors affecting modern Israel businesses, the labor market and HR issues, and Israel consumer behaviors. We will also schedule discussions with graduate students at universities we will visit; our plans include time working collaboratively with entrepreneurs in residence in a University-based incubator, and a one day "startup boot camp- "Israeli style."
- Third, we will get exposure to the culture and economy of Israel, with guided tours of Jerusalem, including Yad Vashem, The Western Wall/Old City and Machne Yehuda open air market in Jerusalem, Sonora Market and the Port in Tel Aviv, a kibbutz in the Negev Desert, Hybrid Incubator for Palestinians in Nazareth, and various other sites of economic, cultural and historical significance. We will participate in a traditional Shabbat dinner on Friday night-a time when technology is set aside and there's time for self-reflection and to "just chill and connect-with self and others." You will also have some free time to do your own exploring.

#### **Description of Selected Assignments**

- 1. Pre-Trip Paper-from the provided content, you will write a 5 paper

- 2.
